I further agree to individually indemnify and hold harmless the Released from any and all claims and causes of action, known and unknown, or proceedings of any nature whatsoever that might arise as the result of injury to myself while engaged in this activity and/or event. The obligation to indemnify will include, but not be limited to, any and all fees, costs, expenses, award of damages, and actual attorney fees incurred in the defense of any proceedings against the Released brought by me, any representative appointed to represent me, or any other person. I understand that this activity and/or event would not be made available to me at this cost if I were to choose not to sign this release and agree that the opportunity to participate at the stated cost in return for the execution of this release is additional good and valuable consideration for this agreement.
